## HAWKER ART EXHIBITION CONDITIONS OF ENTRY

**Artists are invited to exhibit original paintings and drawings.**

1. There will be a maximum of 10 exhibits per artist showing at any one time. Exhibits will be removed when sold and replaced. More than 10 exhibits per artist may be accepted. Please refer to back page of this entry form.
2. **Maximum overall size of works (including frame) is 95cm X 95cm.** To ensure secure hanging, exhibits must have wire affixed one third of depth from top of frame. Please leave a little slack in the wire.
3. The Exhibition Committee reserves the right to withhold any exhibit from the Exhibition.
4. All exhibits to be for sale. A commission of 25% will be charged on all exhibits sold during the Exhibition.
5. Minimum sale price of a painting shall be \$45.
6. **An entry fee of \$5 per exhibit ( a pair is 2 exhibits )** shall accompany each entry form. Cheques, money orders, etc to be paid to 'Hawker Art Exhibition'. The entry fee is non-refundable.
7. The greatest care will be taken of all exhibits. The Exhibition Committee will insure exhibits from 1 September to 1 October for loss or damage while in its custody or control, but will not insure in transit to and from Hawker. The exhibitor must meet all freight costs to Hawker. Return freight will be borne by the Exhibition Committee up to a maximum of \$20 per artist.
8. All exhibits must clearly bear: the **artist's name, address, title, medium and price on the back of the exhibit.**
9. Name and address of exhibitor must appear on the outside of all packaging.
10. Unsold exhibits are (unless otherwise requested in writing):  
 (A) to be collected 12 noon till 5pm Sunday 28 September, or  
 (B) ) to be dispatched by Wednesday 1 October by Stateliner bus transport
11. The Exhibition Committee reserves the right to have any exhibits reproduced in the press or on television.
